

## Blarney Castle Can-Am Giveaway Rules – November, 2018

- 1) Contesting begins on November 1, 2018 and ends November 30, 2018.
- 2) **How to Enter:**
  - a. No purchase is necessary to enter this contest.
  - b. To enter, go to any Blarney Castle EZ Mart and fill out an official entry form.
  - c. Only one entry per person will be accepted.
  - d. No liability is assumed for misdirected entries.
- 3) **Eligibility Restrictions:**
  - a. This contest is open to adults over the age of 21.
  - b.
