## **CREDIT AGREEMENT - HOME HEATING ACCOUNT**

- PURCHASES: Blarney Castle Oil Co. (BCOC) will deliver, subject to availability, fuel oil or propane
  at our established price, which is determined at the time of delivery. Deliveries will be made to Buyer
  (you) at the address shown on this agreement on an automatic delivery basis, unless otherwise noted
  on this agreement according to a Weather Controlled Degree Day System. A meter printed delivery
  ticket will be left or mailed at the above address each time a delivery is made.
- 2. PAYMENT: You agree to accept each delivery and to pay the full amount shown on each delivery ticket accordingly within 15 days of delivery. Terms may be changed by BCOC at any time based on your payment history or credit standing.
- 3. MONTHLY STATEMENT: If you have a delinquent balance in your account, we will send you a monthly statement. It will show separately your purchases, the FINANCE CHARGE, and the date the payment is due.
- 4. FINANCE CHARGES: Unless you paid the previous balance shown on your monthly statement in full by its due date, a FINANCE CHARGE will be added to your purchases account from the date of purchase and these FINANCE CHARGES will be computed in the following way:
  - (a) We start with the previous balance of your purchases account at the beginning of the billing period.
  - (b) Each day of the period we subtract payments and credits and add purchases, giving us the daily balance.
  - (c) We then average the daily balance (called "balance subject to FINANCE CHARGE") and multiply this average by the following monthly rate: .583% on the full balance, which is an ANNUAL PERCENTAGE RATE of 7%
- 5. DEFAULT AND COLLECTION COSTS: You will be in default if you do not pay a balance on time, file for bankruptcy, or make an assignment for the benefit of creditors. Default means we can demand immediate payment of the full balance. If we refer collection of the balance to a lawyer, you will pay attorneys fee of 33% of the total balance plus court costs.
- 6. IRREGULAR PAYMENT AND DELAY IN ENFORCEMENT: We can accept later payments or partial payments, or checks and money orders marked "payment in full" without losing any of our rights under this agreement. We can also delay enforcing our rights under this agreement without losing them.
- 7. AMENDMENT OR CHANGES: We can change this agreement including FINANCE CHARGE and the ANNUAL PERCENTAGE RATE, at any time, provided we give you at least 30 days notice before the beginning of the billing period in which the change becomes effective.
- 8. CANCELLATION: We or you can cancel your account at any time on 30 days written notice. You agree to remain responsible for payment for all purchases made before the 30 days period expires. We also have the right to cancel your account without notice if you fail to make payments on time.
- 9. LIABILITY: We are not responsible for damage or loss caused by failure to make delivery due to labor shortage, strikes, or to conditions beyond our control. In the event of DEFAULT, and we do not deliver fuel oil or propane as a result of DEFAULT, we will not be liable for any damages in either or indirect manner.
